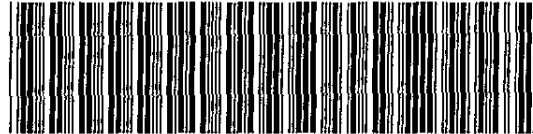



The manager and the members of Scott Transport LLC hereby amend the Articles of Organization of Scott Transport LLC as follows:


- (a) The name of this limited liability company is presently Scott Transport LLC.
