**ARTICLE VI - AMENDMENT**

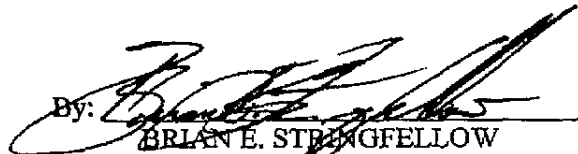
