**ARTICLES OF ORGANIZATION
OF
VK HOLDINGS TREVISO BAY MARINA, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be VK HOLDINGS TREVISO BAY MARINA, LLC (the "Company").

ARTICLE II - ADDRESS

The mailing address and initial principal office of the Company shall be 19275 West Capitol Drive, Suite 100, Brookfield, Wisconsin 53045.


