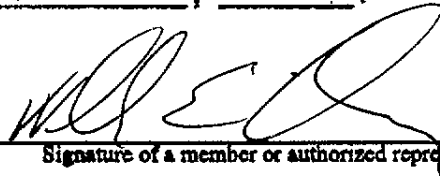
FIRST: The Articles of Organization were filed on May 4, 2004 and assigned document number L04000035235.
