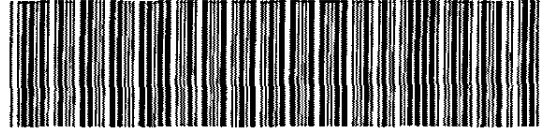



EXISTENCE**


