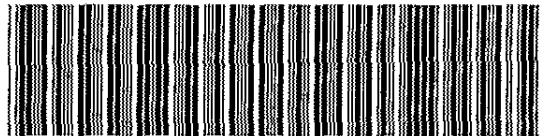

ARTICLES OF ORGANIZATION

The Undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. 608, does hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I : NAME

ARTICLE II: DURATION

The Company shall commence its existence on the date it records its Articles of Organization.

The Company's existence shall terminate not later than December 31, 2014, unless the Company is shall earlier dissolve as provided in its Articles of Organization and/or Regulations.

ARTICLE III: PURPOSE AND POWERS

The Company shall have the power to carry out its business and affairs, including without limitation all of those powers set forth in Chapter 608 of Florida Statutes.

ARTICLE VII: ADMISSION OF ADDITIONAL MEMBERS

The right, if given, of the members to admit additional members and the terms and conditions of such admissions shall be as follows:

No additional members shall be admitted to the Company without the written consent of members representing not less than fifty percent (50%) of the capital interest of the Company, and upon such terms and conditions as shall be determined by members representing not less than fifty percent (50%) of the capital interest of the Company.

A member may transfer his/its interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the Company or become a member unless the other members representing not less than fifty percent (50%) of the Company other than the member proposing to dispose of his/its interest, approve of the proposed transfer by written consent.

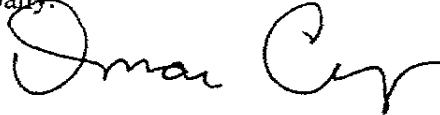
ARTICLE VIII: MEMBERS RIGHTS TO CONTINUE IN BUSINESS:

The Company shall be automatically dissolved by the death, insanity, bankruptcy, retirement, or expulsion of any member or member-manager without further action from the members.

Neither the Articles of Organization for the Company, nor the Regulations of the Company, after having been once filed, and having been once approved, can be amended other than by a vote representing not less than fifty percent (50%) of the capital interest of the Company.
