

ARTICLES OF ORGANIZATION CARPENTRY MASTERS, LLC

The Undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Act, F.S. 608, does hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I: NAME

The name of the limited liability company shall be:

ARTICLE VII: ADMISSION OF ADDITIONAL MEMBERS

The right, if given, of the members to admit additional members and the terms and conditions of such admissions shall be as follows:

No additional members shall be admitted to the Company without the written consent of members representing not less than fifty percent (50%) of the capital interest of the Company, and upon such terms and conditions as shall be determined by members representing not less than fifty percent (50%) of the capital interest of the Company.

A member may transfer his/its interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the Company or become a member unless the other members



representing not less than fifty percent (50%) of the Company other than the member proposing to dispose of his/its interest, approve of the proposed transfer by written consent.

ARTICLE VIII: MEMBERS RIGHTS TO CONTINUE IN BUSINESS:

The Company shall be automatically dissolved by the death, insanity, bankruptcy, retirement, or expulsion of any member or member-manager without further action from the members.

ARTICLE IX: AMENDMENTS TO ARTICLES AND REGULATIONS

Neither the Articles of Organization for the Company, nor the Regulations of the Company, after having been once filed, and having been once approved, can be amended other than by a vote representing not less than fifty percent (50%) of the capital interest of the Company.
