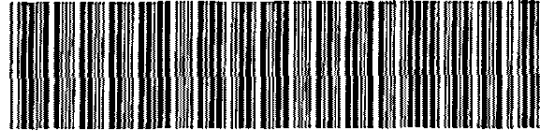



ARTICLE III - REGISTERED AGENT, OFFICE AND AGENT'S SIGNATURE




