ARTICLES OF ORGANIZATION for INTEGRITY INSURANCE AGENCY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Integrity Insurance Agency, LLC ("Company").

ARTICLE II - STREET ADDRESS

The street address of the principal office of the Company shall be 400 North Wymore Road, Suite 110, Winter Park, Florida 32789.

ARTICLE III - MAILING ADDRESS

ARTICLE IV - DURATION

The Company is to exist perpetually.

ARTICLE V - PURPOSES AND POWERS

The general purpose for which the Company is organized is operate an Insurance Agency and to transact any other lawful business for which a limited liability company may be organized under the laws of the State of Florida as approved by the Members of the Company. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE VIII - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.
