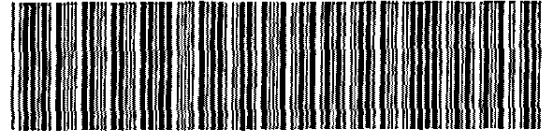

ARTICLES OF ORGANIZATION

FOR

B. POLACEK PARTNERS, LLC

A Florida Limited Liability Company

ARTICLE I
NAME

The name of the limited liability company (the "Company") is B. Polacek Partners, LLC.

ARTICLE II

ARTICLE VII
AMENDMENT

The power to adopt, alter, amend or repeal the Articles of Organization or the Operating Agreement of the Company shall be solely vested in the Members of the Company.

ARTICLE VIII

The initial Operating Agreement of the Company shall be adopted by its Members. The Operating Agreement may contain any provision for the regulation and management of the affairs of the Company not inconsistent with the laws of Florida or these Articles of Organization.

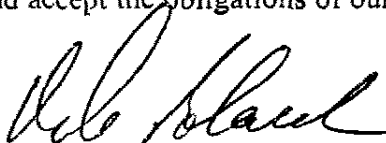
