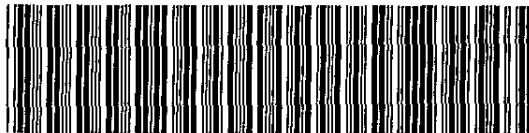

THE UNDERSIGNED certifies he intends to form a limited liability company under the laws of the State of Florida and hereby declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the limited liability company (the "Company") shall be **MICHAEL J. WIDICK, L.C.**

**ARTICLE II
ADDRESS**

The mailing and street address of the Company's principal office is:

**ARTICLE III
PURPOSES**

The general nature of the business or businesses to be transacted and which the Company is authorized to transact shall be as follows:

- A. To engage in any activity or business authorized under the applicable statutes including, but not limited to, the ownership, operation and management of a business providing legislative and lobbying services to the public.
- B. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the states in which the Company does business, and to do any and all things herein set forth to the same extent as a natural person might or could do.

**ARTICLE IV
DURATION**

The duration for the Company is perpetual.

ARTICLE V
REGISTERED AGENT AND OFFICE

ARTICLE VI
MANAGEMENT

The Company is to be managed by a manager or managers. The name and address of the initial Manager who is to serve as Manager is **MICHAEL J. WIDICK**, whose address is 3685 Buttonwood Way, #1524, Naples, Florida 34112.

ARTICLE VII
ADMISSION OF NEW MEMBERS

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.

ARTICLE VIII
CONTINUATION OF BUSINESS OPERATIONS

The Company may continue its business operations upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in a limited liability Company only upon the unanimous approval of the remaining members.

ARTICLE IX
TRANSFERABILITY OF MEMBER'S INTEREST

A member's interest in the Company shall not be transferred unless the transfer is approved by the members in accordance with the Company's Regulations.

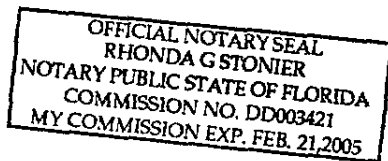
