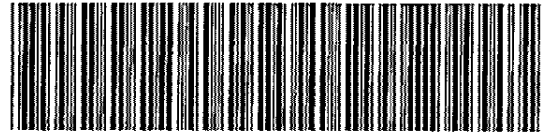

**ARTICLES OF ORGANIZATION**  
**OF**  
**ROBERT W. ORMSBY, LLC**

**ARTICLE I -- NAME**

The name of the limited liability company shall be **ROBERT W. ORMSBY, LLC**, ("company").

**ARTICLE II -- ADDRESS**

The mailing address and street address of the principal office of the company is **5802 Wire Grass Trail, Valrico, Florida, 33594**.

**ARTICLE III -- DURATION**

The company shall commence its existence on the date these articles of organization are signed by the organizer or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

**ARTICLE V -- CAPITAL CONTRIBUTIONS**

#### ARTICLE VIII -- MEMBERS' RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of all the remaining members.

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. 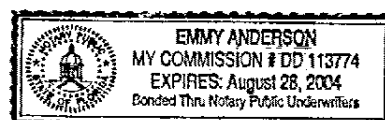
