Article V Effective Date and Duration

The period of duration for the Company is perpetual. The effective date of the Company shall be May 7, 2004.

Article VI Management

The Company is a manager-managed company.

Article VII Continuation of Business

The death, retirement, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the professional services company will not cause a dissolution of the Company, and the remaining members (including successor members) have the right to continue the business of the professional services company.

Article VIII Nature of Professional Business

- A. - B. The ownership interest representing the equity interest of the member whose interest is terminated because of the application of the preceding paragraph shall not thereafter be entitled to voting rights (except as provided hereinafter in regard to liquidation and dissolution or amendment), dividends, options, or stock rights of any kind.
- C. The ownership interest owned by such person shall forthwith be transferred, sold, purchased, pledged or redeemed at such price or value and under such terms as are authorized or set forth in the operating agreement of the Company, if any, and if not, by mutual agreement or, if no such agreement can be reached within a reasonable time under the circumstances (and any event within thirty (30) days), then by arbitration in accordance with the Florida Arbitration Code then in effect.
