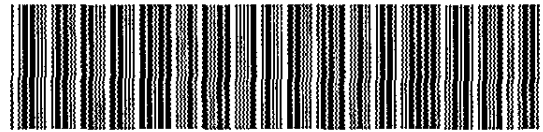

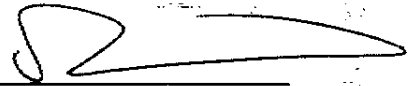

ARTICLES OF ORGANIZATION

OF

The undersigned authorized representative hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 4335 Cheval Blvd., Lutz, Florida 33558, and the initial registered agent of the Company at such office shall be KYRIACOS MAVROS. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE IV

Operating Agreement
