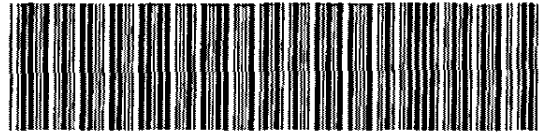

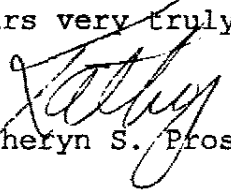

**ARTICLES OF ORGANIZATION
OF
TMS COMPANY LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act").

ARTICLE I: The name of this limited liability company ("the company") is TMS COMPANY LLC.

ARTICLE II: The initial principal office and mailing address of the company is 1275 County Road 210 West, Jacksonville, Florida 32259.

ARTICLE III: The name and address of the company's initial registered agent are FRED M. WILLIAMS, 1275 County Road 210 West, Jacksonville, Florida 32259.
