NAME

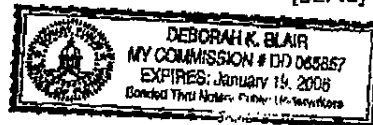

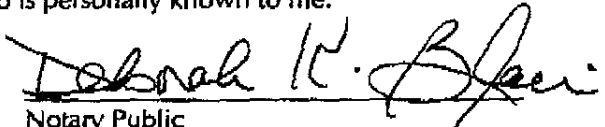
