## ARTICLES OF ORGANIZATION

#### OF



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### **ARTICLE 1 - NAME**

The name of the limited liability company shall be PITA GOURMET LLC, ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 1605 Boardman Avenue, West Palm Beach, Florida 33407 and the mailing address shall be the same.

#### **ARTICLE 3 - EFFECTIVE DATE**
