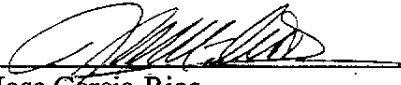
Article IV. Duration

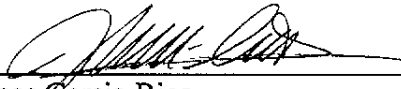
