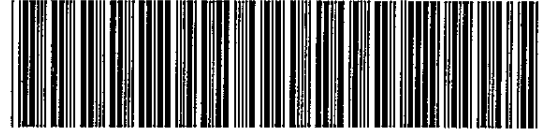

ARTICLE VII - Effective Date:






