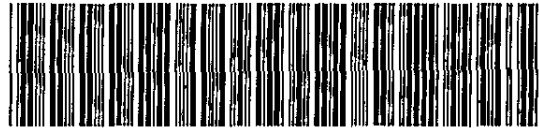




Pursuant to the provisions of section 607.1006, Florida Statutes, this Limited Liability Company adopts the following Amendment of its Articles of Organization:
