ARTICLES OF ORGANIZATION OF MSA INVESTMENTS LIMITED LIABILITY COMPANY

The undersigned certifies he is a member of a group that has associated for the purpose of becoming a limited liability company under the laws of the State of Florida, which provide for the information, rights, privileges, and immunities of limited liability companies for profit. He further declares that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE VI MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all members.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue business on unanimous consent of the remaining members.

ARTICLE VII CAPITAL CONTRIBUTIONS
