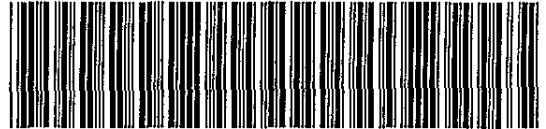



**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
Y-NOT-7, LLC  
(A Florida Limited Liability Company)**
