#### ARTICLES OF ORGANIZATION

OF

# PROSPERITY POWER TRAINING LIMITED LIABILITY COMPANY

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes (the "Florida Limited Liability Company Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida, does set forth the following:

#### 1. NAME

The name of the Limited Liability Company is Prosperity Power Training Limited Liability Company (the "Company").

# 2. PERIOD OF DURATION

The Company shall have a perpetual period of duration. The Company may be dissolved sooner, however, as provided in the Florida Limited Liability Company Act or the written Operating Agreement to be executed by all of the Members of the Company.

#### 3. <u>PURPOSE</u>

The purpose for which the Company is organized is to shift the global paradigm about money and abundance by offering simple holistic training and education in prosperity and abundance principles and techniques, to engage in charitable giving, and to engage in any and all other businesses and activities permitted by the laws of the State of Florida. #### 6. INITIAL CAPITAL CONTRIBUTIONS

The total amount of cash and a description of the agreed value of property other than cash contributed to the Company is as follows: One Hundred and No/100 Dollars (\$100.00) in cash.

#### 7. ADDITIONAL CONTRIBUTIONS

The total additional contributions, if any, agreed to be made by all Members and the times at which such contributions shall be made, are as follows: No total additional contributions have been agreed to as of the date of filing of these Articles of Organization. Additional contributions, if any, will be made as provided in the Operating Agreement.

#### 8. **CONTINUITY OF BUSINESS**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the business of the Company shall be continued and the Company shall not be dissolved without the prior written consent of all the remaining Members of the Company.

#### 9. **EFFECTIVE TIME**

These Articles shall be effective when filed with the Florida Department of State.
