ARTICLES OF ORGANIZATION OF ANGEL RECORDS BY GPC, LLC.

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida statutes, entitled the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

ARTICLE I Name

The name of the limited liability company, hereinafter referred to in these Articles as "Company," ANGEL RECORDS BY GPC, LLC

ARTICLE II Address

The Company's mailing address and street address of its principal place of business in Florida is 9209 NW 49th Place, Sunrise, FL 33351, but it shall have the power and authority to establish branch offices at such place or places as may be designated by the members.

ARTICLE III Duration/Continuation

Beginning on the date these Articles of Organization are filed with the Florida⁷¹ Department of State, the period of the Company's duration shall be perpetual, unless terminated by the unanimous written agreement of all members or by the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminated the continued membership of a member unless the business of the company is continued by the consent of all the remaining members, or by amendment of these Articles of Organization providing for the continued existence of the Company subsequent to the foregoing events.

ARTICLE IV Purpose

Members shall have the right to admit new members by unanimous consent.

Contributions required of new members shall be determined as of the time of admission to the Company. A member's interest in the Company may not be sold or otherwise transferred except with unanimous written consent of all members.

ARTICLE VII Powers

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction, of the members of the Company.
