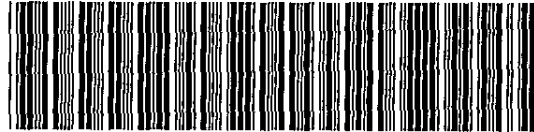

The name of the Limited Liability Company is: COMREALTY.NET OF WEST PALM BEACH, LLC ("Company").




