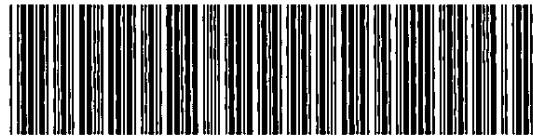

SECOND: The date of the adoption of these Articles of Dissolution is 7 May 2007.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
