ARTICLES OF ORGANIZATION OF LANDEAL, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited D 3: 02 Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following PORIGITA RY OF STATE Organization.

ARTICLE I - NAME

The name of the limited liability company shall be LANDEAL, L.L.C. (the "Company").

ARTICLE II - PURPOSE




