The undersigned does hereby form a Florida Limited Liability Company under the laws of the state of Florida.

The LLC shall, to the fullest extent permitted by the provisions of the Florida Limited Liability Company Act, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities, or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any operating agreement, vote of members or managers, or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased

to be a member or manager and shall inure to the benefit of the heirs, executors and administrators of such a person.

3. Any action required or permitted to be taken at a meeting of the members may be taken without a meeting upon the written consent of members who would have been entitled to cast the minimum number of votes that would be necessary to authorize the action at a meeting at which all shareholders entitled to vote thereon were present and voting.

SIXTH: The effective date for these Articles of Organization shall be the date of filing.
