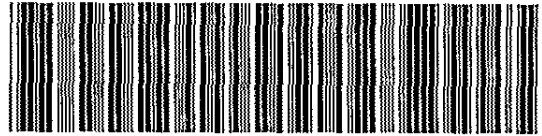



ARTICLES OF ORGANIZATION
OF

4. Place of Business. The mailing and street address of the Company's principal office is 3292 Green Dolphin Lane, Naples, Florida 34102.




