The mailing address and street address of the principal office of the Limited Liability Company is 912 Rotonda Circle, Rotonda West, Florida 33947-1838.

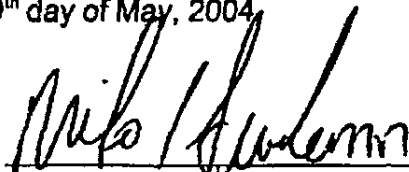

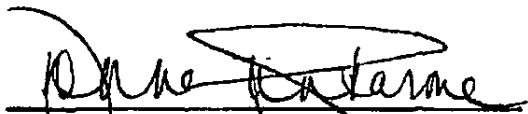

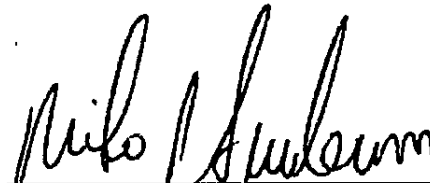
