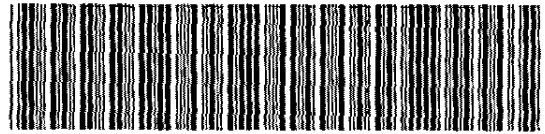

ARTICLE I

NAME

The name of this limited liability company is 163 SIESTA DRIVE, LLC, referred to in these Articles of Organization as the "Company."

ARTICLE II

**PRINCIPAL OFFICE, MAILING ADDRESS AND
REGISTERED AGENT**

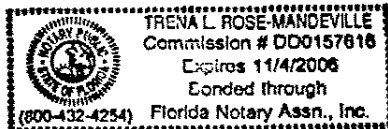


