# **ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby adopts the following Articles of Organization.

# **ARTICLE I**

The name of this limited liability company is X Plex, LLC, with its principal office located at 453 Woodstock Drive, Port Orange, FL 32127.
