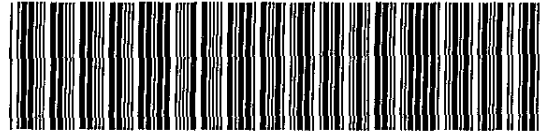

Management by Members**

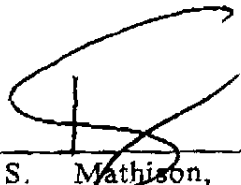

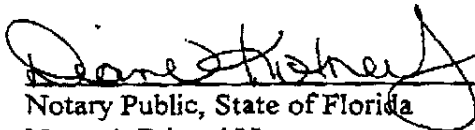

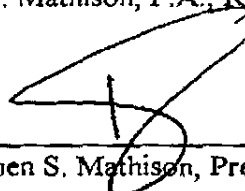
