**ARTICLES OF ORGANIZATION
OF

The undersigned person hereby adopts these Articles of Organization in order to form a limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE I - NAME

The Company shall be managed by a manager or managers and is, therefore, a manager-managed company.


ARTICLE VII - ADOPTION OF OPERATING AGREEMENT
