

1. Name. The name of this limited liability company is **TITAN ASSOCIATES, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The existence of the Company shall be effective as of May 21, 2004, and shall thereafter be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.


4. Place of Principal Office. The mailing and street address of the Company's principal office is 601 Bayshore Boulevard, Suite 960, Tampa, Florida 33606.
