FOR
FLORIDA LIMITED LIABILITY COMPANY**

**ARTICLE 1
NAME**

The name of the limited liability company shall be I & G Drywall Hangers LLC

**ARTICLE 11
PRINCIPAL PLACE OF BUSINESS AND ADDRESS**

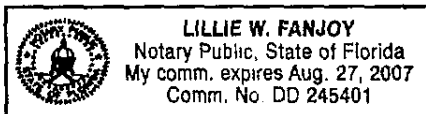
