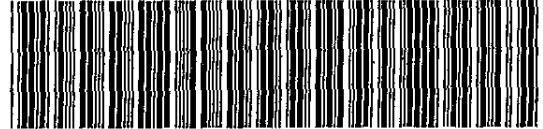

**Articles of Organization for SAKAE FOUNDATION, L.L.C.  
a Florida Limited Liability Company (FS 608.407)**

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

**ARTICLE I – NAME**

The name of this Company shall be SAKAE FOUNDATION, L.L.C.

**ARTICLE II – PURPOSE**

This Company is formed for real estate holding and investment and for operation of a karate training center, and to provide all manner of services in connection therewith. 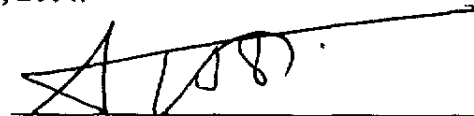
ARTICLE VIII – INDEMNIFICATION

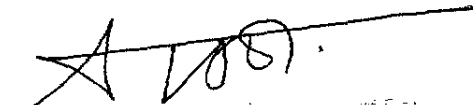

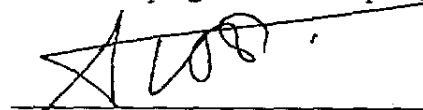
