ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statute Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I — NAME

The mailing address and street address of the principal office of the company is 12472 Allport Road, Jacksonville, Florida 32258.


ARTICLE III — DURATION

ARTICLE V — MEMBERS' RIGHT TO CONTINUE BUSINESS



ARTICLE VI — MANAGEMENT


