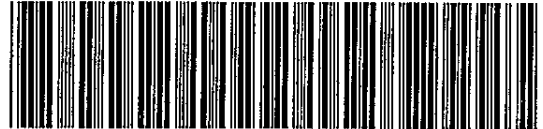

ARTICLES OF ORGANIZATION

OF

SUPER V PROPERTIES, LLC

The undersigned, desiring to form a limited liability company under the provisions of Florida Statute 608, as amended, hereby sets forth the following:

ARTICLE I

Name

The name of the Limited Liability Company is SUPER V PROPERTIES, LLC (hereinafter referred to as the "Limited Liability Company")

ARTICLE II

Principal Office & Mailing Address

The principal place of business and mailing address of this Limited Liability Company shall be c/o 1474 Jordan Hills Court, Clearwater, FL 33755.

ARTICLE III

Duration



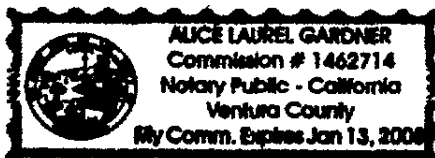
