
ARTICLE VI

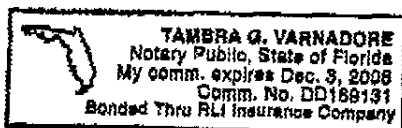

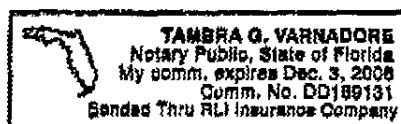


