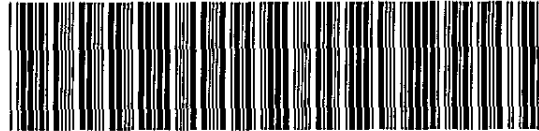

**CONTINUATION AFTER INVOLUNTARY TERMINATION**


