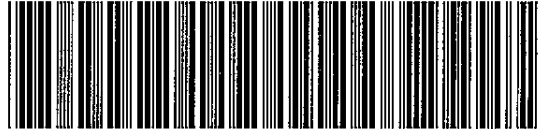

The undersigned, as a member or an authorized representative of a member of the Company pursuant to Chapter 608, Florida Statutes, files the following Articles of Organization establishing a Florida Limited Liability Company named JEA, LLC.

**ARTICLE I.
NAME**

The name of the Limited Liability Company shall be:
