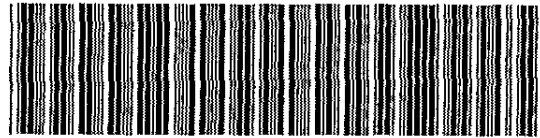

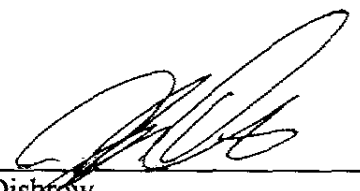
ARTICLE V. – MANAGEMENT

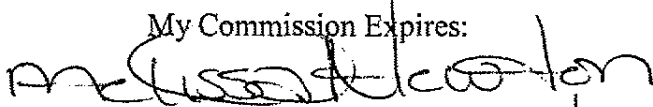
