

ARTICLES OF ORGANIZATION

OF

ZOO HOLDINGS, L.L.C.

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **ZOO HOLDINGS, L.L.C.**

ARTICLE II - ADDRESS

THE MAILING ADDRESS and street address of the principal office of the Limited Liability Company shall be 4251 North Washington Boulevard, Sarasota, Florida 34234.

ARTICLE III - DURATION

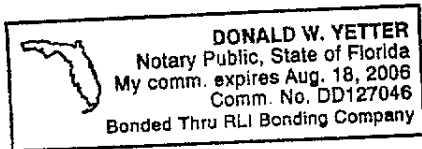
