**ARTICLES OF ORGANIZATION  
OF

The undersigned person, acting as the organizer of KDJ & J 30<sup>th</sup> STREET, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

**ARTICLE I - NAME**

ARTICLE X - TERMINATION OF MEMBERSHIP INTEREST

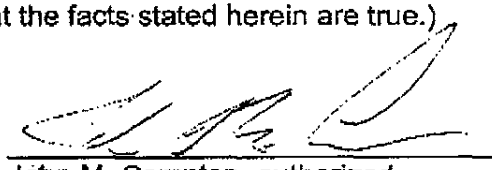
