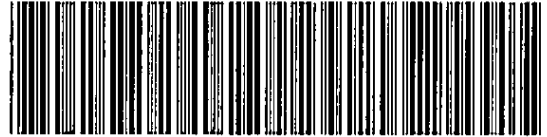

FIRST: Amendment adopted: The name of this Limited Liability Company is hereby amended to read : Mallory Townhomes, LLC


