ARTICLES OF ORGANIZATION OF

733 Rivlera, LLC,

a Florida Limited Llability Company



The undersigned, being the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

ARTICLE I

The name of the limited liability company shall be **733 Riviera**, **LLC**, a Florida limited liability company (the "Company").

ARTICLE II PRINCIPAL PLACE OF BUSINESS

The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations.
