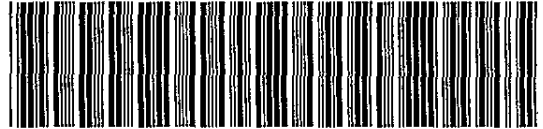

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I — NAME

The name of the limited liability company shall be INFLATABLE SMILES, LLC ("company").

ARTICLE II — PURPOSE

The purpose of this company is to engage in all lawful business subject to statutes and regulations of the State of Florida.

ARTICLE III — ADDRESS

The mailing address and street address of the principal office of the company is 1105 Tropic Street, Titusville, Florida 32796 .

ARTICLE IV — DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

ARTICLE V — REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is Regina Stanford, 1105 Tropic Street, Titusville, Florida 32796.

ARTICLE VI — CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash or property set forth in Exhibit "A".

ARTICLE VII — ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

ARTICLE VIII — ADMISSION OF NEW MEMBERS

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the

members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the Operating Agreement of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

#### ARTICLE IX — MEMBERS' RIGHT TO CONTINUE BUSINESS

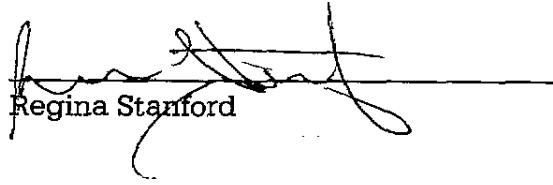

#### ARTICLE IX — MANAGEMENT

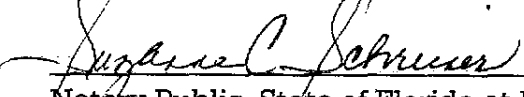
