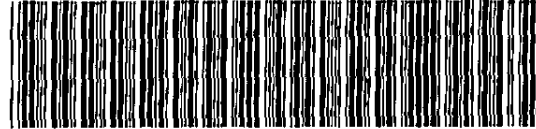




FIRST: THE Articles of Organization were filed on May 27, 2004, effective May 26, 2004 and assigned documents number L04000040297.
