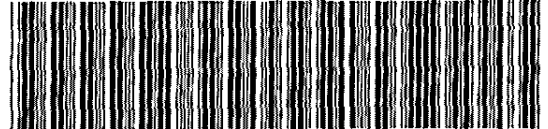

**ARTICLES OF ORGANIZATION
OF
GOODON, L.L.C.**

The undersigned hereby certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles of Organization for such limited liability company:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name of this limited liability company is GOODON, L.L.C., and its principal office and mailing address is located at 761 S. Kirkman Road, Orlando, Florida 32811.

**ARTICLE II
DURATION**

The existence of this limited liability company shall be perpetual, commencing upon the filing of the Articles of Organization by the Florida Department of State.

**ARTICLE III
PURPOSE**

The purpose of this limited liability company is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV
DISSOLUTION**

The limited liability company will dissolve as provided in the Operating Agreement executed by and among its members.

**ARTICLE V
MANAGEMENT**

This organization is to be managed by a manager or managers elected by a majority vote of its members. The initial manager, who shall serve until the earlier of their death, resignation, replacement or until the first annual meeting of members and her successor is elected and qualified, shall be PATTY GOODON, MGR.

**ARTICLE VI
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this limited liability company shall be located at 761 S. Kirkman Road, Orlando, Florida 32811, and the initial registered agent of the limited liability company at that address shall be PATTY GOODON.

IN WITNESS WHEREOF, the undersigned, has executed these Articles of Organization for this limited liability company this 25th day of May, 2004.


